- Complete the relevant nomination form

- Individuals confirming that the Advisory/Consultancy service has been provided to such Institutions / Individuals.
- A document explaining the Product and its uniqueness as to the reasons for nomination (maximum of 500 words)

Preliminary Documents to be submitted:

- Profile (maximum 250 words)
- Any other specific reasons why the organization deserves the award
- Product profile, with specific reference to the Islamic Banking/Finance and Letter of Award/Institution in the respective Country
- Awards won and other recognitions obtained during the said period

Selection Criteria:

At the heart of the selection methodology is the comprehensive research undertaken by AlHuda CIBE. There are two ways nominations are determined. The first is where nominations are accepted from industry players who would like to be considered for a National Islamic Banking and Finance Awards in a particular category. This is the case for "Self Nominations." The second is where the research team recommends to the Nominations Committee the names of the institutions and individuals, which their research supports for a National Islamic Banking and Finance Awards. These prestigious awards provide ample opportunities to everyone in the industry to compete by excelling in their respective fields and promoting themselves through media and other means of communication.
